last Date 31-03-2019.**

Whereas, Ministry of Home Affairs Government of India issued a notification dated 11-09-2018 received through ALIS Portal which reads as UIN generation of Old Licenses.

Whereas, it was made known by the medium of issuing numerous public notices to Arms License Holders to approach the judicial section of undersigned to get their Arms Licenses uploaded on MHA website i.e ALIS.

Whereas, this office has issued Arms Licenses to various individuals and Army, Security persons from time to time residing in and outside the state which are required to be uploaded on NDAL portal only up to 31/03/2018 as notified by the Ministry of Home Affairs vide Notification dated 11-09-2018 received through ALIS.

Whereas, no Arms Licenses shall be renewed without having Unique Identification Number, no any other transaction further shall be made on the license as per the MHA guidelines disseminated vide above quoted notification and the license become invalid after 31/03/2019 if not registered.

Whereas, the physical response regarding ALIS for generation of Unique Identification Number with respect to Arms license as on date is very poor which is again sought to be hastened by the medium of this notice within stipulated time period: and


Now therefore, all the license holders who have their Arms Licenses issued from the office of undersigned are hereby informed by the



medium of this notice to approach the Judicial section of undersigned to get their Arms Licenses uploaded on ALIS by or before 31/03/2019. No license shall be entertained for generation of Unique Identification Number with respect to Arms Licenses, renewal or any other transaction after the due date & time and the left out licenses shall be treated as in valid after 31/03/2019. This is the last opportunity for registration of Arms Licenses as for the dates mentioned above.
