
The approval is subject to the following terms and condition:-

1. The Block Development Officer/Programme Officers shall prioritize only those works which are permissible under MGNREGA guidelines/circulars issued by the Government of India/State Government from time to time.
2. Only those works shall be taken up which are permissible under the scheme and shall be strictly as per the norms/guidelines of the MGNREGA.
3. The Block Development Officer/Programme Officer ensure that the works are new and have not been earlier executed under any other scheme.
4. The works are for the benefit of community and are not of religious/personal nature.
5. The works shall be taken in hand subject to the availability of funds and actual labour demand.
6. The approval accorded is provisional and actual execution of works depends upon the availability of funds.

7. The works are taken up only after getting the administrative approval and technical sanction of competent authority.
8. A unique identity shall be given to each work and all works must be executed by the workers who have job cards and who demanded for employment.
9. The implementing agency shall not engage any contractor/machine in the implementation of the scheme.
10. The Block Development Officer shall ensure that works are dispute free and qualitative.
11. The implementing agency shall display the details of each works to be taken up for execution in the Gram Sabha/Panchayat Offices for information of general public and also put the details of works on MIS of the scheme.
12. The measurement of the work will be recorded in the measurement book maintained by the qualified technical personal incharge of the work site and measurement record of each work and work shall be available for public inspection.
13. A citizen's information board must be put up at every work site and uploaded regularly.
14. The estimates of works shall be within the limits of plan provision/agreed labour budget and in no case the estimate/administrative approval/technical sanction shall exceed plan provision/agreed labour budget.
15. The Block Development Officer/Programme Officer shall ensure installation of sign boards at all the work places indicating nomenclature, date of start, completion date, estimated cost of work, year of construction and name of scheme etc. The provision of sign boards may be kept in estimates.
16. District Informatics Officer shall formulate complete GPS Mapping of all th bridges for which BDOs will provide coordinates.
17. Forest Department will be approached by BDOs for requisition of timber wherever required.
18. Serial number of bridges, project name and convergence details shall be reflected on display board of each bridge.
19. No foundation stoned lying or inauguration ceremony or announcement shall be made by anyone except prior approval of District Development Commission in consultation with stakeholders/ donors.
