**CIRCULAR**

It is bring into the notice of all transport unions of Jammu region that Delhi based NGO namely MAMTA with support from India HIV AIDS Alliance (Alliance India) under Global Fund Round - 4 is implementing project Vihaan in 3 states of North India namely Himachal Pradesh, Uttarakhand and Jammu & Kashmir.

It is not out of place to mention here that MAMTA in collaboration with J & K society for promotion of youth and Masses convened a meeting on 28<sup>th</sup> May 2015 at Hotel Premier which was chaired by undersigned and attended by all union presidents from Jammu region wherein, it was discussed that all terminally ill patients have to travel twice a month to Bakshinagar hospital to take medicine and it was finally decided and consented by all the Union Presidents that all terminally ill patients will avail monthly two times free travel in local Mini buses / Buses etc. The bus pass shall be issued by care and support centre, Jammu and duly signed by Medical superintendent, Govt. Medical college, Bakshi Nagar, Regional Transport officer, Jammu and Transport union president of concerned areas.

Therefore, in view of above, all union presidents are requested to sensitize their employees i.e. drivers and cleaners about free bus pass and travel of such terminally ill persons to Bakshi Nagar, Hospital. Further, while doing so, due care should be taken that there should not be any stigma and discrimination while dealing with such patients.

Therefore, accordingly all the Union Presidents of Mini Buses / Buses of different routes of Jammu Province are requested to implement the said decision so to facilitate the terminally ill patients.


