**Sub: Permission for entry of Heavy Vehicles/Trucks/Load Carriers in Udhampur City-regarding.**

**ORDER**

Whereas, in order to check frequent traffic jams in congested area of Udhampur City and to ease the inconvenience caused to the commuters and students, this office vide Order issued under Endorsement No.3080-89/DMU/JC dated 05-08-2015, has prohibited/banned entry of all heavy vehicles/load carriers/Commercial vehicles in the Town on Rehmbal-Jakhani route via Udhampur Town and Jakheni-Rehmbal route via Udhampur Town.

Whereas, representations of Transport Companies dealing in Transport business viz. M/S Gurdeep Singh & Co., Udhampur, M/S Chandan Motor Service, Udhampur etc. have been received requesting therein for allowing the entry of heavy vehicles/load carriers in the City from 08.00 PM to 7.00 AM on the plea that due to restrictions on entry in the City, their business is being affected badly.

Whereas, in order to redress the various representations/requests received in this regard, a committee headed by the Additional Deputy Commissioner, Udhampur, ARTO, Udhampur, Dy.SP (Traffic) Udhampur, Tehsildar Udhampur and SHD, Udhampur as its members was constituted vide this office Order issued under Endorsement No. DDCU/61/2015-16/10560-10566 dated 05-10-2015 to furnish its report to this office within a week's time so as to arrive at an amicable decision.

Whereas, the aforesaid Committee constituted vide No. PS/ADC/2015/128 dated 15-10-2015 has furnished its recommendations that heavy vehicles be allowed to enter into the Udhampur Town from 09.00 PM to 06.00 AM for which necessary passes shall be issued by the ARTO, Udhampur in favour of the President of the Transport Union only after proper verification.

Therefore, keeping in view the recommendations of the Committee as well as the requests of Transport Companies made from time to time and in partial modification of this office Order quoted herein above, it is hereby ordered that entry of Heavy Vehicles/Trucks/Load Carriers in Udhampur City shall be permitted from 09.00 P.M. to 06.00 A.M. for which necessary passes shall be issued by the ARTO, Udhampur in favour of the President of Transport Union only after proper verification.

This order shall come into force with immediate effect and remain in force unless rescinded earlier. This order shall not apply in case of government Agencies for departmental purpose. This order shall be notified for the information of the general public by affixing copies of this order on the public notice board of the various offices of Police, Transport, Revenue Department and Municipal Council Udhampur and through print and electronic media.
